This year began with the activation of the Sustainable Development Goals (SDG's) when on January 01 2016, the seventeen (17) SDGs of the 2030 <u>Agenda for Sustainable Development</u> — earlier adopted by world leaders in September 2015 at an historic UN Summit — officially came into force. Now over the course of the next fifteen (15) years, countries all over the world are expected to mobilize efforts to bring an end to end all forms of poverty, fight inequalities and tackle climate change, in an equitable manner. The SDGs follow on the experience of the Millennium Development Goals (MDGs) and have a much larger scope and mandate. While the MDGs proposed in 2000 did not include media in any of its eight Goals, the SDG's give opportunity to recognize media as a relevant actor in the development process, and to highlight how for example, freedom of expression is both a means to and a goal of development. the Goal 16 (Peace, Justice and Strong Institutions), Target 10, aims to ensure public access to information and protect fundamental freedoms, in accordance with national legislations and international agreements – social participation and integration, development decision making and the safe guarding of democratic values all depend on access to information.

However, not just this, all the 17 SDG's – if they are to be achieved, require an informed and robust role of the media in terms of raising awareness, facilitating social mobilization, and ensuring transparency and good governance. Pakistan has also become a signatory to the SDG's and an SDG Secretariat has already been established at the National Assembly Secretariat in Islamabad. Our media now needs to work to holding accountable all vested with the responsibilities of meeting the SDG agenda.

As such, Shehri-Citizens for a Better Environment, in collaboration with the Friedrich-Naumann-Stiftung and Green Media Initiatives is organizing an interactive consultation on SDG's with a particular focus on orienting the media on what the SDG's are, their context and background, how they will roll out, the institutions and stakeholders involved and the relevance and importance for Pakistan. This consultation will be held on Saturday, 21st May 2016 (3:00 pm) at NED University (City Campus), Near DJ Science, College, Karachi.

Topical issues like **'Heat Wave'** will get discussed and relevant experts will engage with media participants to brainstorm on what role the media can play in the implementation of the SDG agenda as it relates to Pakistan.
