# Forging a Community for Green Living

It has become quite evident now that the most potent challenge facing humanity as a whole that also poses as an existential challenge is climate change. For humankind to have any hope for stabilizing our planet, we need a radical shift in our lifestyles. That process is already ongoing and the *green economy* has arrived, becoming the fastest growing economic model in the world now. Knowledge products will also be prepared in the form of published content that may include, thematic car stickers, knowledge brochures and cataloguing of people and organizations involved in producing green products and services.

We are launching this work with an introductory consultative session to be held on **Thursday**, **October 26**, **2023** (**2**:45 – **6**:00 pm) at the Marriott **Hotel**, **Karachi**, where a wide range of formal and informal stakeholders will be present. In this session, we would orient the participants with key objectives and activities of the project and selected speakers would provide a valued backdrop to the project theme by sharing their work.
