KARACHI DEVELOPMENT AUTHORITY NOTICE UNDER ARTICLE 45 OF THE KDA CRDER

(President Order No. 5 of 1957)

DEVELOPMENT OF JACOB LINES

No. 1-16/73-Reg/KAD.—In pursuance of provision of Article 45 of KDA Order (President Order No. 5 of 1957) and in supercession of the previous notice published in the local newspapers on 16th March, 1973 and 17th March, 1973 notice is hereby given that a General improvement-cum-Street Scheme for the area covered by (I) Jacoblines (III) Behind Jacoblines (IV) Jutland Lines (V) Tunisia Lines (VI) Abysinia Lines (VII) Fowler Lines and (VIII) Bizerta Lines, known as KDA Scheme No. 35 has been prepared and is proposed to be executed with the Co-operation of Pak. P.W.D.

The area lies in the heart of the City and consist of mostly old barracks and unauthorised Juggis and is not being put to maximum utilization. As it has got great potential for development, the Scheme No. 35 have been taken up for constructing multistoreyed flats, building of new roads and widening of existing roads, laying of sewers, storm water drains, and water main and other services as well as providing educational and other amenities.

The area covers approximately 698 acres, bounded by M.A. Jinnah Road, Khudadad Colony, PECHS, Sindhi Muslim Housing Society, Jinnah Post Graduate Medical Centre, Drig Road, Frere Street (Aziz Bhatti, N.H. Shaheed Road) and Mansfield Road (Rizvi S.J. Shaheed Road). The boundaries of the area included in the Scheme has been shown on a map of 1:4,000 (16"=1 mile approx) which alongwith the particutars of the Scheme may be seen at the office of the CTP&A, KDA, Shahrah Kamal Ataturk, Karachi during office hours on any working day. Copies of the map be purchased on cost from the said Office.

DETAILS OF THE BOUNDARIES OF THE AREA: A TO Z:

With point 'A' situated at the North West corner of Government Girls High School opposite Capri Cinema on M.A. Jinnah Road, to point 'B' alongwith the Cantonment boundary which runs in the Eastern side of plot Nos. 130 to 123 upto Katrak Road and then along Katrak Road upto point 'C' and then to point 'C1' along Mansfield Street (Rizvi (S.J.) Shaheed Road) and then along Church Street (Amed Munit (S.J.) Shaheed Road) (Southern Boundary of plot Noes. 188, 118/71, 119 & 120) upto the North Western corner of Plot No. 169 and then running along the Western boundary wall of the said plot upto Clerk Street (Shahrah-e-Iraq) and going further south on the Western Side of the Mosque and Police Station at Point 'D' and connecting Point 'D1' (along Western Boundary of Naval Office) the meeting point of Mansfield Street (Rizvi S.J.) Shaheed Road) Old Malir Road (Tufail (N.H.) Shaheed Road and then upto the meeting point of Fere Street (Dr. Dawood Pota Road) and Inverarity Road (Iqbal Shaheed Road) upto Point 'E' and then running along the Western boundaries of Plots 216 & 209 up the meeting point 'F' of Fere Street (Dr. Dawood Pota Road) and Drigh Road and then running along the Southern boundary of Drigh Road upto point 'G' the
