NOTIFICATION OF K. D. A. SCHEME NO. 25-ZONAL PLAN FOR PIPRI-KHANTO AREA

No. KDA/4-30/63-Cordn—In exercise of the powers vested in the Karachi Development Authority (hereafter referred to as the Authority) under Article 45 read with Article 40 of the K. D. A. Order, 1957 (President's after referred to as the Authority has framed a Zonal Plan Scheme No. 25, covering an approximate area of 80 Order No. 5 of 1957), the Authority has framed a Zonal Plan Scheme No. 25, covering an approximate area of 80 Sq. Miles (51, 200 acres) constituting the whole of Dehs Landhi, Khanto, Bokran, Pipri and Joreji, District Karachi, butted and bounded as follows:—

In the North-Malir River and Deh Sanhro, Deh Katiaro and Deh Dhandro.

In the East—Dah Ghaghar and Deh Kohistan of Mirpur Sakro District.

In the South-Gharo Creek.

In the West-Deh Gangiaro and the P. W. R. Main Line up to Malir River.

All the land falling within these boundaries has been earmarked for various uses such as residential, industrial, civic and commercial, open spaces, graveyards etc., as per the K.D.A. Plan bearing No. PB/25/1, dated 8th July 1964.

No person shall be permitted to make use of the land in contravention to the uses shown in the plan of the Scheme. All building operations, quarrying, digging, allotments and sales shall be subject to the approval of the K. F. A., as provided under Article 41 of the K. D. A. O der. Violations of these provisions shall be dealt with as a preach of the provisions of the K. D. A. Order.

Objection³ to the Scheme, if any, may be forwarded to the Chief Town Planner and Architect, 4th Floor K. D. A. Head Office Building, Shahrah Kamal Ataturk, Karachi within a month from the date of this Notice.
